ICCs Advise and Assist Lead Agencies

- 1. Identify sources of fiscal and other support for services
- 2. Assign financial responsibility to the appropriate state agency
- 3. Promote methods for interagency collaboration including financial responsibility and provision of early intervention services
- 4. Help prepare the Part C application




